

## Pet Parent Agreement

Thank you for giving me the opportunity to take this journey with you and your four-legged family member. Together, we will create a plan to reach your training goals. I encourage you to keep in mind that every training plan is fluid and your dog's learning curve, emotions, and needs will always take the lead on this path you have made the choice to take.

The Pet Parent Agreement is a contract between you—the pet parent—and **Puppy Parade LLC** to ensure a successful journey.

**The Pet Parent is Signing Up For: In-home private training for \_\_ sessions (\_\_ series).**

After each session, the Pet-Parent will receive an email within 24 hours recapping the session and a homework assignment for the Pet-Parent. Puppy Parade LLC encourages the Pet Parent to review the email and reach out to Puppy Parade LLC for guidance to help you and your dog succeed. **\_\_\_\_\_ (initial here)**

It is the pet parent's responsibility to inform **Puppy Parade LLC in writing via email** if the Pet Parent needs to cancel or reschedule a training session for any reason. **Puppy Parade LLC requires 48 hours minimum notice for all cancellations or rescheduling requests. Any cancellations that are less than 48 hours in advance will be counted towards the Pet Parent's series and will not be able to be rescheduled as a make-up session.** If the Pet Parent informed Puppy Parade LLC within the required time frame, a make-up session will be rescheduled at no extra cost if it is rescheduled within the session due date. **\_\_\_\_\_ (initial here)**

Puppy Parade LLC does not permit the use of prong collars, choke chains, bark collars, or any other aversive mechanisms during the training series. Puppy Parade LLC uses positive reinforcement methods only.. Should the pet parent use prong collars, choke chains, bark collars, or any other aversive mechanism, the Pet Parent will be in breach of the Pet Parent Agreement. **\_\_\_\_\_ (initial here)**

**Puppy Parade LLC** requires immediate notice from the Pet Parent, in writing via email, during the series period for the following:

- Your dog is ill, injured, developed fleas, or any contagious condition.
- Your dog was involved in any dog bite situation;
  - “Dog bite situation” means the dog was either bit by animal or the dog bit an animal or human;
  - “Bit” or “bitten” means has been seized with the teeth or jaws so that the person or animal seized has been nipped, gripped, wounded, or pierced, and further includes contact of saliva with any break or abrasion of the skin.
- If you or any member of your household is ill or you have come into contact with anyone who is ill, even if you are not showing symptoms. \_\_\_\_\_ **(initial here)**

**Puppy Parade LLC** and the Pet Parent agree it’s the Pet Parent’s responsibility to ensure the safety of the Pet Parent’s pet or pets at all times before, during, or after each training session. \_\_\_\_\_ **(initial here)**

The Pet Parent agrees to release **Puppy Parade LLC** from all liability of any nature including injury, sickness, damage, and death the Pet-Parent’s pet and/or property may endure before, during, or after any training session. . \_\_\_\_\_ **(initial here)**
